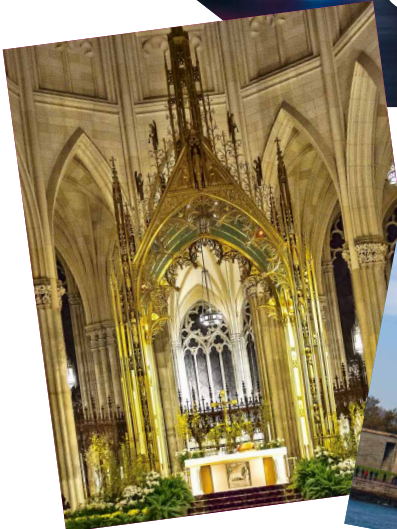

Later visit **Central Park** for the **Macy's Thanksgiving Parade Balloon Inflation** to see how the parade balloons come to life. The event provides an exciting preview of the larger-than-life characters you'll see in the next day's parade. This evening enjoy time at leisure to explore this vibrant city or maybe take in a Broadway Show on your own.

## DAY 3: NOVEMBER 26TH THANKSGIVING DAY MACY'S PARADE

This morning attend the annual **Macy's Thanksgiving Day Parade**, a New York City tradition since 1924. This afternoon visit **The Metropolitan Museum of Art**, one of the world's largest and finest art museums. ## DAY 4: NOVEMBER 27TH 9/11 MUSEUM - ONE WORLD OBSERVATORY - CIRCLE LINE CRUISE - BROADWAY SHOW

Then visit the **9/11 Memorial Museum**, a moving experience located within the archaeological heart of the World Trade Center which documents the impact of the events and explores the continuing significance of September 11, 2001. Later visit **One World Observatory**, positioned on top of the tallest building in the Western Hemisphere, on levels 100, 101, and 102 of the 1,776 foot tall One World Trade Center building, One World Observatory provides unique, panoramic views of New York City, its most iconic sites, and surrounding waters. Later experience a **Manhattan Landmarks Cruise** on the world famous Circle Line Cruises. The sightseeing cruise glides by the towering One World Trade Center, cruises feet away from the Statue of Liberty, and offers breathtaking views of lower Manhattan before

quietly slipping under the Brooklyn, Manhattan and Williamsburg Bridges on the East River. This evening "head out in the city" for a fun filled evening. Start with a **Pre-Theatre Farewell Dinner** at a popular local restaurant. Later see an exciting **Broadway Show** with your fellow travelers in the world's most famous theatre district.

### Part A - Cancellation Waiver provided by PWD

**I. Trip Cancellation Waiver (TCW)** - Guarantees full refund on all payments, except the TPP Fee itself in case of cancellation up to the time and date of departure due to the passenger's personal illness or death of a member of the immediate family; or, if the passenger must return early due to the passenger's personal illness or death of a member of the immediate family, a refund for the unused land services. Medical/official documentation required.

**II. Premier "Any Reason" Cancellation Waiver (ARCW)** - Reimburses 75% of the cancellation fees in the form of a future travel credit certificate (FTCC) valid for 1 year, if you cancel more than 48 hours prior to scheduled departure for any reason not eligible for cash refund under the TCW (Part A - I.). FTCC is non-transferable, may not be redeemed for cash and does not include any credit for the TPP Fee. The TPP Fee (if chosen) is refundable until 180 days prior to departure & cannot be added after Final Payment.

**The TPP does not cover any single supplement charges due to an individual's traveling companion cancelling prior to departure.** The TPP is non-transferable and valid for each applicant only. The TPP does not cover any services such as airline tickets not purchased through PWD. Cancellations, Claims & Inquiries under Part A will be administered by PWD.
